















How to submit the Milestones on MEL

Note: There are different steps to finalise the Milestones on MEL, depending on its status:

<u>Option 1</u>: When the Cluster leader or co-leadet has reviewed the original Milestone. In this case the «**Propose**» button is marked by a red i.

5 <u>Option 2:</u> When there have been no proposed changes to the original Milestone, or a new milestone has been added. The **«Approve**» button in this case is enabled.

Option 1, first step: Click on «Propose» to review the proposed changes on the Milestone.




